

ARTIST LICENSING AGREEMENT

This Artist Licensing Agreement (the "AGREEMENT") is entered into effective this date,

All references to the Gallery in this Agreement shall include Gallery's parent companies, affiliates, and subsidiaries.

Recitals

Gallery produces, exhibits and sells digital/printed artwork; and Artist has created and owns the digital assets, or digital images of artworks listed in the List of Licensed Artwork (collectively known as "IMAGES") and desires to grant the Gallery to produce artworks or derivatives from the Images, exhibit and sell them; Therefore, the parties agree as follows:

Scope of Agency. The artist appoints the gallery to act as artist's exclusive/ non-exclusive agent in the following geographic area: _____ for the exhibition and sale of artwork in the following media: _____.

This agency shall cover only artwork submitted by the artist while this agreement is in force.

License and Right: All Images and rights relating to them, including copyright and ownership rights in the media in which the Images are stored, remain the sole and exclusive property of the Artist. This license provides the Gallery with the right to: (i) use, modify (as appropriate in connection with the print-on-demand services and shipping of printed Images), reproduce, distribute, sell, publicly perform and publicly display the Images; and (ii) access, view, use, crop, resize, copy, distribute, license, publicly display, publicly perform, transmit and broadcast copies of the Digital Works in any form, medium or technology now known or later developed, for the purpose of promoting the Gallery and the its services. The Gallery may appoint one or more third party subcontractors, who may exercise the license rights above for the purpose of enabling the Gallery to process and fulfill orders for printed Images. Artist shall sign the Certificate of Authenticity for artworks sold as the requirement of the Gallery.

License of Artwork: The Gallery produces the artworks or derivatives from the Images according to the Artist's requirement. The form, royalty and other details are listed in the appendix List of Licensed Artwork.

Pricing and Payment: The Gallery shall pay the Artist royalty per each piece sold specified in the List of Licensed Artwork. Royalties due in a particular month shall be paid within 30 days of the end of such month.

Accounting: The Gallery shall furnish the artist with an accounting every _____ months. The first such accounting to be given on the _____ day of _____. Accounting shall identify each artwork sold during the accounting period.

Duration and Termination of Licensing: The Artist and the Gallery agree that the initial term of license for the artwork shall continue until _____, 20___. Thereafter, this agreement shall continue until written notification of termination from either party to the other. Within thirty days of the termination notification, all accounts shall be settled. The agreement shall automatically terminate with the death of the artist or if the gallery becomes bankrupt or insolvent, or breaches the agreement.

Representations and Warranties; Disclaimer: Artist hereby represents and warrants that (a) Artist has the full power and authority to enter into this agreement and to perform Artist's obligations hereunder, and that the performance of such obligations will not conflict with or result in a breach of any agreement to which Artist is a party or is otherwise bound; (b) the Images do not infringe, misappropriate or otherwise violate any copyright or other intellectual property or proprietary rights of any third party; and (c) Artist has the unrestricted right to grant the licenses and rights granted under this agreement free and clear of any encumbrances, liens, or claims of any nature.

Miscellany. All modifications, deletions or additions to this agreement must be in writing and signed by both parties. This agreement constitutes the entire understanding between the parties hereto.

General Law/Arbitration: This Agreement sets forth the entire understanding of the parties, and supersedes all prior agreements between the parties. This Agreement shall be governed, interpreted and enforced in accordance with the laws of the State of New York.
